PRESS RELEASE

This May, the New York State Fraternal Order of Police will be honoring 40 Law Enforcement Officers who have died in the Line of Duty while serving the citizens of New York State.

Every year we come together as a profession to remember our brothers and sisters who have made the supreme sacrifice. Since 1791, more than 23,000 heroes, across this Nation, have selflessly laid down their lives in the line of duty. The NYS FOP Memorial Wall has enshrined upon it the names of more than 1,400 members of the NYS law enforcement community so that their names will forever be ingrained in our hearts.

In addition to memorializing the 2 Line of Duty losses we experienced this year, we are remembering 13 Brothers and Sisters who lost their lives to Covid-19 and 25 Brothers and Sisters who have succumbed to 9-11 related illnesses. This year, our solemn ceremony will commemorate their loss and pay special tribute to their service.

The tradition of honoring those who died in the Line of Duty will commence promptly at 10:00am on May 7th, at the Empire State Lodge of the Fraternal Order of Police, located at 911 Police Plaza, Hicksville, NY. I hope that you will be able to join us in honoring the fallen members of our profession.
